Samaritan Aviation provided medical, mission and aviation support in Papua New Guinea In 2011 we air evacuated over 50 critically ill or injured individuals, almost half of these were mother's in distressed Our float plane delivered lifesaving medicine to two villages with cholera outbreaks We also supplied over 15 thousand pounds of medical supplies to 28 village aid posts Samaritan Aviation provided Mercy Flights for 13 individuals, some more than once during 2011 that were too ill to travel by road or commercial airline In several of the flights we were able to fly the patients to medical appointments which allowed them to return to the comfort of their own home in the same day We also follow-up with flight patients & their families to offer our continuous support through our organization
